Objective

The welfare of animals is a significant concern in the modern livestock industry (including retailers). Scientific evidence suggests that animal welfare is closely related to production performance and product quality.

Animal welfare also contributes directly to animal, human and environmental health, being a key component of the One Health and One Welfare concepts. Citizens and consumers are increasingly aware of the ethical issues of common practices in livestock production and are concerned about the protection of welfare of farmed animals.

Considering the relevance of animal welfare, the EU adopted a series of rules and measures setting standards for the protection of farmed animals at farm, during transport, and at slaughter. In parallel with the legislation, several certification and labelling schemes have been developed in recent years. These certification schemes aim to offer consumers food of animal origin produced under conditions that ensure a higher level of animal welfare than legally required. Several certification schemes co-exist on the market, differing in aspects such as the certification system, the species covered, and the criteria and welfare indicators used.

The implementation of meaningful animal welfare legislative measures and certification schemes requires extensive knowledge, as well as considerable human and economic resources. Awareness of the current EU animal welfare legislative framework, the different certification and labelling schemes and how these schemes interact with current legislation and with other types of certification (e.g. environmental) is crucial for the livestock professionals and contributes to optimise decision-making at business level in this sector. This course will cover these aspects and aims to provide in-depth knowledge on the dimensions and scientific background of farm animal welfare, as well as a comprehensive view on its EU regulatory framework.

At the end of the course, participants will:

- understand the scientific, economic and cultural background for the animal welfare concept;
- be aware of the different indicators used to measure animal welfare;
- know the current EU animal welfare legislation and its institutional arrangements;
- know the characteristics of different certification and labelling schemes available in Europe;
- be aware of the economic and social impacts when implementing certification and labelling schemes.

Organisation

The course is jointly organised by the International Centre for Advanced Mediterranean Agronomic Studies (CIHEAM), through the Mediterranean Agronomic Institute of Zaragoza (CIHEAM Zaragoza); the Food and Agriculture Organization of the United Nations (FAO) within the framework of the FAO-CIHEAM MoU; and the Ministry of Agriculture, Fisheries and Food (MAPA) of Spain, through the General Directorate of Health and Agrifood Production and Animal Welfare; with the collaboration of the European Commission, through DG SANTE, and the Red Científica en Bienestar Animal (Red CIBA).

The course will be given by well-qualified lecturers from international organisations, universities, research centres and competent authorities from different countries and will be held at CIHEAM Zaragoza over a period of one week, from 25 to 29 November 2024, in morning and afternoon sessions. There are two participation options: a) face-to-face with access to lectures, case studies and practical works or b) on line with access to lectures and case studies via live streaming. The programme will be delivered in English.

The course requires personal work and interaction among participants and with lecturers. The international characteristics of the course favour the exchange of experiences and points of view. Lectures are complemented by case studies and practical work. The practical work will focus on improving the skills of participants in measuring animal welfare and a role game devoted to the creation of a certification scheme.

Admission

The course is designed for professionals with a university degree, and oriented towards public and private planners and decision-makers, technical advisors and livestock producers, stakeholder organisations, auditors and researchers, involved in the development and implementation of animal welfare plans and regulations. Academics working in related topics are also welcome to apply.

- 30 places will be available for face-to-face participation with access to lectures, round table discussion and practical work (30 hours).
- 30 places will be available for online participation with access to lectures and the round table discussion via live streaming (24 hours).

Knowledge of English will be valued in the selection of candidates as it will be the working language of the course.

- The deadline for the submission of applications is 14 July 2024. If places are still available after this date, the deadline will be extended to 30 September 2024 for candidates not requiring a visa or a scholarship.
- Applications from candidates requiring authorisation to attend the course may be accepted provisionally.
- Registration fees for the course amount to 500 euro for face-to-face participation and 350 euro for online participation. This sum covers tuition fees only.

Scholarships

Candidates from Mediterranean CIHEAM member countries and FAO member countries from the Middle East and North Africa may apply for scholarships covering registration fees. In some cases, scholarships may cover the cost of travel and full board accommodation.

Candidates from other countries who require financial support should apply directly to other national or international institutions.
